

# Colorado Tribal Contacts

## Introduction

The "Colorado Tribal Contacts List" has been developed with assistance from the National Park Service NAGPRA Grants program, and is produced through an interagency partnership between the Colorado Commission of Indian Affairs and History Colorado. The directory is designed for cultural resource managers and others wishing to contact tribes with a legacy of occupation in Colorado.

Per executive memorandum "Government-to-Government Relations with Native American Tribal Governments" (59 FR 22951), federal agencies are required to consult with Indian nations on a government-to-government basis. As always, those using this list are advised to confirm each tribe's consultation protocol and contact information for each project.
